

# **Sunderland Association Football Club Limited and Dafabet**

## **Dafabet Cup Competition Terms & Conditions**

### **1. Definitions**

**“SAFC”** means Sunderland Association Football Club Limited; **“Dafabet”** means Dafabet (Asian Logic); **“the Winners”** means those individuals who are selected to play in the Competition; **“the Promoter”** means Dafabet.

### **2. General**

The competition (**“the Competition”**) involves the chance to play for Sunderland AFC in a five-a-side football tournament between fans of Sunderland AFC, Burnley FC, Celtic FC, and Everton FC at the Sunderland Stadium of Light on Friday 19 May 2017 (**“the Dafabet Cup”**).

### **3. Restrictions**

The Competition is open to residents of the UK and Ireland aged 18 (eighteen) years and over only. Employees (and members of their immediate family) of SAFC, Dafabet or any group companies of SAFC or Dafabet, their agents and anyone connected to the Competition are not eligible to enter.

### **4. Rules to participate**

- 4.1 All entrants must be aged 18 (eighteen) years or over.
- 4.2 All entries must be submitted via the SAFC website [www.safc.com](http://www.safc.com) between midnight on 26<sup>th</sup> May 2017 and midnight on Friday 5<sup>th</sup> May 2017. Entries submitted before the opening date and time and/or after the closing date and time will not be considered.
- 4.3 Entrants will not be restricted from entering further competitions during the same campaign.
- 4.4 By entering into the Competition, all entrants consent to their name and image, and any quotes obtained from them utilising the Prize, appearing on both SAFC and Dafabet Facebook, twitter feeds, and related media content.
- 4.5 The Competition is free to enter and no purchase of any goods or services is necessary.
- 4.6 There is no charge to register with SAFC’s website.
- 4.7 By entering this Competition, all entrants warrant that the information they have provided is true, accurate and complete. SAFC and Dafabet reserve the right to verify the age and eligibility of all entrants.

## **5. Prize(s)**

- 5.2 A team of 8 (eight) players will be selected by SAFC to play in the Dafabet Cup (“the Winners”). The Winners will be required to confirm their attendance in the Dafabet Cup and provide their UK sizing for shirts and shorts within 24 hours of being contacted by SAFC. SAFC shall endeavour to provide kit for each of the Winners based on the sizing details given, subject to availability.
- 5.3 If the Winners do not confirm their attendance within the required time period set out above, or are unable to attend the Dafabet Cup for any reason, then SAFC shall be entitled to select another Winner to participate in the Dafabet Cup.
- 5.4 The Winners will each receive, courtesy of SAFC, the chance to play for Sunderland AFC in a five-a-side football tournament at the Sunderland Stadium of Light on Friday 19 May 2017 when they will compete against fans of Burnley FC, Celtic FC, and Everton FC to win the Dafabet Cup. The Winners will also receive full SAFC club kit (consisting of shirt, shorts and socks only, football boots will not be provided) (“**the Prize**”).
- 5.5 The Winners shall be liable for all and any accommodation, travel and other expenses required in order to avail of the Prize.
- 5.6 There are no alternatives to the Prize. The Prize is as stated and is non-exchangeable, non-transferrable, and no cash alternative is offered. If due to circumstances beyond the control of SAFC or Dafabet, SAFC is unable to provide the Prize, SAFC and Dafabet reserve the right at all times to substitute the Prize with another prize of similar value or carry the Prize forward to an alternative date suitable to SAFC and Dafabet.

## **6 Results**

- 6.1 The Winners will be selected by SAFC. The decision of SAFC regarding any aspect of the Competition is final and binding and no correspondence will be entered into about it.
- 6.2 If the Winners cannot be traced after reasonable efforts have been made by SAFC, SAFC will be entitled to select an alternative Winner from the entries.
- 6.3 Notification of the Winners will be posted on [www.SAFC.com](http://www.SAFC.com), the official website of SAFC, and the official SAFC Twitter account, after the close of the competition.

## **7 General Conditions**

- 7.1 Any entry which does not comply with the rules may be deemed invalid at the sole discretion of SAFC or Dafabet. Neither SAFC nor Dafabet are responsible for technical, hardware or software malfunctions, misdirected entries, lost or unavailable network connections, failed, incorrect, garbled, delayed electronic or other communications or other technical problems related to mobile entries. Proof of sending will not be deemed to be proof of delivery.

- 7.2 All entrants agree and accept that they may be required to participate in publicity relating to the Competition without further consent or payment. Such publicity may include publication of their names and photographs in any media.
- 7.3 SAFC will advise Dafabet of the number of entries and traffic volume to each competition.
- 7.4 By entering this competition, participants are deemed to have accepted and agreed to be bound by these Terms and Conditions and by any other requirements set out in the promotional material. SAFC and Dafabet reserve the right at any time to modify, amend, or discontinue, either temporarily or permanently, the Competition with or without prior notice. SAFC and Dafabet reserve the right to refuse entry, or refuse to award the Prize, to any participant who acts in breach of these Terms and Conditions.
- 7.5 The Prize will involve intense physical activity for at least 90 minutes. Participation in the Competition and the Dafabet Cup is therefore entirely at the entrants' own risk. All entrants must therefore ensure that they are fit enough to participate in the Dafabet Cup, and confirm that they have no illness, injury or medical condition which would prevent them from doing so. Entrants should seek medical advice and guidance if they have any doubt as to their fitness to participate.
- 7.6 Subject to condition 7.7 below, SAFC and Dafabet accept no responsibility or liability and shall not be responsible or liable for any damage, loss, liabilities, injury, or disappointment incurred or suffered as a result of entering or participating in the Competition and/or the Dafabet Cup, or winning, accepting, or using the Prize.
- 7.7 Nothing in these terms and conditions shall exclude or limit the liability of SAFC or Dafabet for any death, personal injury, fraud or fraudulent misrepresentation suffered as a result of negligence on the part of either SAFC or Dafabet.
- 7.8 SAFC and Dafabet shall not be liable if the Competition or Dafabet Cup is postponed or cancelled, or where any failure to comply with their obligations is caused by something which is outside their reasonable control, including, but without limitation, any inclement weather conditions, fire, flood, hurricane, act of terrorism, strike, industrial action, war, hostilities, political unrest, riots, civil commotion or any government legislation.
- 7.9 The Promoter of the Competition is Dafabet, operated by Asian BGE (Isle of Man) Limited, which is a limited company licensed in the Isle of Man and situated at First Floor, Jubilee Buildings, Victoria Street, Douglas, Isle of Man, IM1 2SH.

## **8 Data protection**

- 8.1 In order to participate in the Competition participants must provide certain personal information. This personal information is collected and processed for the purposes of organising, running and monitoring the campaign, as well as for carrying out publicity activities on it.

- 8.2 The Promoter shall be considered the data controller for the database containing this personal information.
- 8.3 In entering into the competition, you agree that SAFC may use your data for promotional purposes and will only pass your data onto third party suppliers insofar as this is required for the fulfilment of the Competition.

## **9 Jurisdiction**

This Competition and the rules are governed by English Law and any disputes will be subject to the exclusive jurisdiction of the Courts of England.
